Minutes of the Ordinary Meeting of the Council held on Wednesday 8th January 2014 in the Village Hall, Erpingham

<u>Present</u>: Mr D Clayton, Mr R Daniels, Mr B Foord, Mr R Goodliffe, Mr N Smith (Chairman), Mr P Watson, Mr A Witham; and 7 members of the public.

- 1. The Chairman welcomed all those present; apologies were received from G Gladden (MUGA).
- 2. Declarations of interest AW as member of the MUGA group; NS for item 6.2 (refund of payment to RCC)
- 3. The <u>minutes of the Ordinary Meeting</u> of the Council held on Wednesday 13th November 2013 were approved, subject to a minor addition under Members' Reports, proposer DC, all in favour, and signed.

4. Matters arising

- 4.1 <u>NCC Highways matters</u> the Clerk relayed the advice from NNC about the removal of a tree trunk from the roadside on the Erpingham/Calthorpe boundary; a highway inspection visit is due shortly. He confirmed that he had been in touch with the police regarding the theft of the grit bin on the A140. He was asked to arrange the purchase of a replacement, for delivery to AW; and to ask NCC if siting could be nearer to the A140 carriageway, which might improve security.
- 4.2 <u>Village sign (Calthorpe)</u> RG advised that a meeting was to be arranged in Calthorpe.
- 4.3 Footpaths nil further
- 4.4 <u>Community Speedcheck scheme</u> Calthorpe names were identified which the Clerk would add to those in Ingworth to establish a volunteer team.
- 4.5 <u>MUGA</u> the line marking is not expected until the Spring as their installation is weather-dependent. An Agreement for the Village Hall Committee was presented to the meeting. The trees for planting to comply with the planning condition were expected imminently.

The Chairman adjourned the meeting to hear from members of the public. Helen Burrell talked about possible activities to be associated with the 600th anniversary of the Battle of Agincourt, including a mediaeval banquet, an archaeological dig, school involvement, a Henry V play, a reenactment society event and a display at St Mary's church. There were two main objectives — whole village involvement and restoration of the St Mary'ss, a Grade 1 Listed building. She sought involvement from the Parish Council, currently given by AW. The Chairman thanked HB for her briefing and with no other public comments the meeting resumed.

5. Planning

- 5.1 Calthorpe Farms, change of use agricultural to office (13/1074) permitted.
- 5.2 Side extension at Fairview, The Street (13/1243) development permitted.
- 5.3 Other planning matters the Chairman indicated that a planning application had been submitted for the Erpingham Arms PH, which the Council would await.

6. Finance
