Minutes of the Ordinary Meeting of the Council held on Wednesday 10th July 2013 in the Village Hall, Erpingham

- 1. The Chairman welcomed everybody; apologies from Mr G Gladden, and Cllr J Timewell (NCC).
- 2. <u>Declarations of interest</u> AW as member of the MUGA project team.
- 3. The minutes of the Annual Parish Meeting and the Annual Meeting of the Council held on May 8th 2013 were approved, proposer DC, all in favour, and signed.

4. Matters arising

- 4.1 <u>NCC Highways matters</u> DC and the Clerk had had discussions with the Highways Engineers about the provision of kerbing on The Street to prevent water run-off. The Clerk was asked to follow this up.

8. Multi-Use-Games-Area (MUGA) project

- 8.1 <u>Village Hall Committee agreement</u> this had been circulated to members and the Council discussed the proposed 'agreement'. The Council recognise the need to formalise responsibilities arising from the MUGA and felt that a 'Memorandum of Understanding' should be prepared. This would set out the Council's obligations in managing the MUGA, and AW stressed that running costs should not impact the precept.
- 8.2 <u>MUGA administration</u> a paper on this had been circulated to members and the Council welcomed this contribution which had so clearly identified areas for action. Details would need further discussions.
- 8.3 Other MUGA details a letter from the Chairman about the MUGA construction had been delivered to all households. AW advised that the electricity supply works were scheduled for 9/9, with a connection on 11/9. The MUGA team would solicit quotes for supply, for which the Parish Council would be the customer. The Clerk was asked to contact the Council's insurers to identify the cover required.

9.1 <u>Clerk's report</u> - in his report the Clerk advised that the Annual Report had been distributed to all villagers with the help of the Chairman. He confirmed that the CEO and Leader of NNDC would attend the Council meeting in November when there would be an opportunity for members to put to them issues of concern in the parish where NNDC can have an impact.
