# Minutes of the Ordinary Meeting of the Council held on Wednesday 14th November 2012 in the Village Hall, Erpingham

Present: Mr D Clayton, Mr B Foord, Mr R Goodliffe, Mr N Smith (Chairman),

Ms G Thorne, Mr A Witham.

- 1. The Chairman welcomed those present with apologies for absence being received from Mr R Daniels.
- 2. Declarations of interest DC for item 6.4 (payments)
- 2a. <u>Emergency Procedural Item</u>: The Chairman explained that the Localism Act 2011 did not give the members dispensation to discuss the setting of the precept as they had a disclosable pecuniary interest as Council Tax payers. The Council agreed to authorise the Clerk, as Chief Executive Officer, to grant dispensation to members of the Council until May 2015 to discuss and decide matters in which the members have DPI (disclosable pecuniary interest). The Clerk stated that all members of the Council would have that dispensation.
- 3. The <u>minutes of the Ordinary Meeting of the Council</u> held on September 12th 2012 were approved, proposer DC, all in favour, and signed.

## 4. Matters arising

- 4.1 <u>NCC Highways matters</u> the Clerk had asked NNDC to remove litter from High noon Road, which had been done. He would follow up with NCC the outstanding item of the overgrown path opposite the Erpingham Arms.
- 4.2 <u>Village signs Calthorpe</u> RG advised that the design was in progress and the provision of a seat was in hand. The Clerk would submit the 'street furniture' approval request.
- 4.3 <u>Footpaths</u> the Clerk had circulated a recent NCC advice on their care of the footpath network and how any maintenance needs can be flagged up. He would alert NCC to the broken finger post near 'The Ark'.
- 4.4 <u>Parish Council website</u> RG and GT with the Clerk had met before the meeting and agreed that the project would progress, with the Clerk beginning to structure the 'off-the-shelf' product arranged through NALC and NCC. Cost would be incurred for domain names and time worked.

- 5.2 N Palmer, extension/porch, 16 The Street, Calthorpe (12/0636) application permitted.

5.5 In other planning business the Chairman relayed to the Council the outline plan for the Village Hall to be extended to provide additional facilities for the Football Club, for which the Committee sought Parish Council approval before submitting a formal application. - 6.3 <u>Precept for 2013-14</u>; the Parish Council decided to set the precept for 2013-14 at £6650, proposer RG, all in favour.
