Minutes of the Ordinary Meeting of the Council held on Wednesday 14th January 2015 in the Village Hall, Erpingham

<u>Present</u>: Mr D Clayton, Mr B Foord, Mr R Goodliffe, Mrs C King, Mr N Smith (Chairman),

Cllr J Timewell (NCC) and 34 members of the public.

1. The Chairman welcomed all those present, and adjourned the meeting to welcome Mr Ed Mumford-Smith, project manager for Broadland Housing Group.

EM-S outlined his brief from NNDC to develop a site on Eagle Lane to provide 8 rent, 4 rent/buy and 12 open market properties. Priority for tenants would be local village residents. There were many questions from the meeting and concerns were expressed as to the impact of the development – traffic, site access, safety for pedestrians on Eagle Road, sewage capacity, electricity overload, waste water drainage, tree preservation and visual impact. Following site surveys and investigations there would be a further consultation at the Village Hall (end February) prior to the planning application. The Chairman thanked EM-S and re-convened the meeting.

- 3. The <u>minutes of the Ordinary Meeting</u> of the Council held on November 12th 2014 were approved, proposer DC, all in favour, and signed.

4. Matters arising

- 4.1 <u>NCC Highways matters</u> with thanks to AW the Council heard that the 'Village Hall' sign at the A140 junction was now in position. A Ranger visit is due shortly and the Clerk was asked to report potholes on Dark Lane.
- 4.2 Village sign Calthorpe; RG confirmed that this was in progress.

5. Planning

- 5.1 Mr J Claxton, convert workshop to accommodation, Chapel House, Chapel Road (14/1050) the application had been permitted.
- 5.2 Anaerobic Digester, Aylsham (Broadland DC 20140630) the application had been refused.

6. Finance

6.1 <u>Finance report</u> – the Clerk had submitted the Council's precept demand for 2015-16, and the Information Commissioner had confirmed the Council's registration for the next year. The Football Club had paid a contribution towards the grass cutting which had been banked. 'FreeParking' had notified the Clerk about the renewal, due shortly, for the website domain name and, following discussion, the Council asked the Clerk to renew it for 3 years, proposer PW, all in favour. The Clerk had circulated the details of the national pay award for Clerks being an hourly increase (2.2% wef 1.1.15) and a small one-off payment.

7. <u>Agincourt 2015</u> -Parish Council involvement – The Chairman and AW updated the Council on activities being planned for the village and it was suggested that the Parish Council should pay for the village Hall to be opened during the 'digs', allowing refreshments to be served. This was agreed, proposer PW, all in favour.

8. Clerk's and Members' Reports

8.1 <u>Clerk's report</u> – Ingworth pc had asked the Clerk to seek the views of the Council about sharing the cost of a SAM2 speed reduction machine. The Council was enthusiastic about the idea but considered the cost would need to be spread over more councils. NS would raise the plan at the next Alby and Colby meetings. The Clerk had received advice from a Charity offering computers to family carers. The next NNDC 'Wider engagement' meeting would be on Wed Feb 4th at 6.30pm in NNDC offices, Cromer.
