# Minutes of the Ordinary Meeting of the Council held on Wednesday 14th March 2018 in the Village Hall, Erpingham

in attendance Mr J Timewell (NCC) and 7 members of the public.

- 1. The Chairman welcomed all those present and apologies were received from Mr G Cox.
- 2. Declarations of interest AW as member of the PCC (item 6.2); DC for payments (item 6.3)
- 3. <u>The minutes of the Ordinary Meeting</u> of the Council held on January 17th 2018 were approved, proposer WG, all agreed, and signed.

#### 4. Matters arising

- 4.1 NCC Highways matters the Clerk had reminded NCC about the branches in the lay-by on Cromer Road, arranged for the pothole on Eagle Road to be filled and passed to them the suggested locations for the 'SAM' Speedwatch device. Further locations of potholes were identified which would be passed to NCC. A site meeting would be arranged re Lodge Lane flooding.
- 4.2 <u>Village sign</u> Calthorpe completion/assembly is in progress.
- 4.3 NNDC dog fouling a new dog waste bin had been ordered and received by DC; signs would be placed as well.
- 5. <u>Planning</u> members discussed the initial moves to de-license the Erpingham Arms and its future potential was explored. No formal applications have been lodged.

#### 6. Finance -

- 6.1 <u>Finance Report</u> in his report the Clerk advised that he had renewed the domain name subscriptions for the pc website; E.ON had notified the Council of a price increase;

6.4 To confirm amendments/updating of Clerk's contract for signature — this had been circulated to all members and the Clerk was able to respond to the queries on pensions and insurance, advising of the existence of a Certificate of Employer's Liability Insurance, and the Pensions Regulator's acknowledgement of Declaration of Compliance. AW expressed his concern that new developments in the village may not focus adequately on the need for young villagers to be prioritised for housing.
