# Minutes of the Ordinary Meeting of Council, Wednesday 13th July 2022

<u>Present</u>: Mr R Goodliffe (Chairman), Mr S Seagrove, Mr A Witham; in attendance (part-time) Cllrs S Penfold (NCC), J Toye (NNDC), and one member of the public

 Mr Rob Goodliffe welcomed all present; apologies for absence were accepted from Mr G Cox, Mr W Goreham, and Mr D Witham. Mrs J Holmes had resigned from the Council. The Clerk would notify NNDC and post the relevant notices.

## 2. Declarations of interest - none

3.The Council approved <u>minutes of the Annual Parish Meeting</u> held on May 11th 2022, proposer AW all agreed, and signed. The Council approved <u>minutes of the Annual Meeting</u> of the Parish Council held on May 11th 2022, proposer SS all agreed, and signed.

#### 4.Matters arising

- 4.1 Highways updates the pothole situation on The Street had notified to NCC and rectification is expected in due course. Response re School Road is awaited, the Council repeating its concern about this road. The next round of parish partnerships projects is active with a closing date of 9/12/22. The Council would revisit possible schemes at the September meeting.
- 4.2 Village Hall/MUGA seating the seats/bin had been delivered and installation would be installed in due course by a contractor, which the Clerk would arrange.
- 4.3 Pond project (The Street) further information awaited

In an adjournment Cllr JT (NNDC) gave an update on current enforcement issues; Cllr SP (NCC) gave out info about his budgets which can be used to support parish initiatives. Options were discussed for improving the one-way priority on Eagle Road. The meeting resumed.

#### 5.Planning

- 5.2 Land east of Village Hall, (21/2713) approval includes restrictions including those to protect the interests of the Village Hall site. This would be monitored.
- 5.3 Other planning business Cllr JT had given an update on the enforcement issues in the parish. A resident had complained to the Clerk about anti-social behaviour related to this.

#### 6. Finance:

6.1 Finance report – the Annual Return had been submitted; transparency compliance had been observed (website/notice boards); the new bank signatories were now active, although the process would resume following JH's resignation – a new signatory was agreed; income items in April and May were VAT reclaim £3271.57, precept £5880.00 and Thwaite pc seat contribution £100.00.
